#### FY 2018/2019 Budget Process

The process is well underway to prepare the FY 2018/2019 budget that takes effect on July 1, 2018. All town departments have submitted their capital and operating budgets, and Town Council will review the Town Manager's proposed budget at a workshop scheduled for February 24th. Residents who are interested in participating in the process are encouraged to attend the following meetings, during which details of the budget will be discussed:

**Town Council Budget Workshop:** The workshop will be held on Saturday, February 24th in the Selectmen's Chamber at Town Hall beginning at 8:00 a.m. and ending by 1:00 p.m. The complete budget calendar is available on-line at: <u>www.avonct.gov</u>.

**Board of Finance Meetings:** The public hearing on the budget will be held on Monday, April 2nd at 7:00 p.m. at the Avon Senior Center. Residents wishing to provide the Board of Finance with input about the budget are welcome to attend.

#### **Town Council Celebrates Streetscape Improvements**

On December 7th, the Town Council celebrated the completion of Phase IV of the Village Center Streetscape Improvement project with a ribbon cutting held at dusk at the entrance to Sperry Park on Simsbury Road (Route 10). Since 2008, the Town has been awarded over \$1.1 million in state grant funding to complete projects aimed at strengthening the Village Center and making it a destination for residential and retail growth in Avon, as recommended by the Town's Plan of Conservation and Development. Phase IV included the installation of sidewalks and decorative carriage lighting along the east side of Simsbury Road. Much of this work was completed in-house by Department of Public Works staff over the course of a year in an effort to reduce costs. The end result of these improvement projects is a more unified and cohesive Village Center area that is welcoming to pedestrians and draws on Avon's unique history and character.



#### **Christmas Tree Pick Up**

### Avon Village Center Update

The Avon Village Center (AVC) development effort continues to move forward. In November 2015, the developer, the Carpionato Group of Johnston, RI, was granted a Master Site Plan approval by the Planning and Zoning Commission for the proposed development located on approximately 97 acres previously owned by Ensign Bickford Industries. Since this approval was granted, a number of design development activities have occurred which will make for a more attractive, well-defined development.

You may have noticed that site work on Phase I of the AVC project began in fall 2016 with the excavation of the property bordering West Main Street (Route 44), Climax Road, and Bickford Drive adjacent to the Avon Town Hall office complex.

Throughout the autumn months of 2017, the Carpionato Group developed plans to relocate a portion of the Farmington Valley Greenway trail out of the Avon Town Hall parking lot and onto AVC property. The new trail segment will have an improved surface, new safety fencing and landscaping. This project is expected to begin in March 2018 and we anticipate that it will continue through the spring. The developer has also agreed to add a few, much needed, parking spaces to the Town Hall parking lot adjacent to the project site.

Though work has occurred on the project site, much of the progress that has been made in the last year has involved the development of the project's design. Since the approval of the Master Plan, frequent meetings have been held with the Carpionato Group, Town staff and the Town's peer review engineer and architect to develop schematic design plans for review and determination by the Planning and Zoning Commission. These schematic designs will specify the proposed locations of infrastructure, roads, and individual buildings.

In recent months, much of the design team's time and effort has been spent ensuring that the AVC development looks, feels and functions as the Planning and Zoning Commission has always intended: a development that embodies the spirit of the Town of Avon and creates a very unique sense of place. For example, the existing historic brownstone buildings and the natural beauty of the Nod Brook will be featured in the design, and public gathering and performance spaces will be integrated into Phase I alongside the retail and residential construction. Another high priority for the design team is to improve connectivity and access to the development for all modes of transportation from both the Town Hall complex and Route 44. All of this design work is being completed in coordination with relevant state and federal agencies to ensure that all regulatory requirements are met to keep this complex project in compliance as it moves forward.

Though this process is a long one, we anticipate that the final product will be well worth the wait. While planning continues, periodic status updates will be presented to the Planning and Zoning Commission as they become available. Ultimately, the schematic plans presented by the design team will be subject to official review and determination by the Planning and Zoning Commission. Additionally, a public hearing is required as part of this process under current zoning regulations. Should the schematic design be approved by the Commission, the developer anticipates moving forward with "vertical development" in spring 2018.

The Planning and Zoning Commission meets the second and fourth Tuesday of the month at 7:00 p.m. in the Selectmen's Chamber. Every meeting and public hearing is open to the public and we encourage members of the public to attend and to ask questions.

### **News from Social Services**

- CT Energy Assistance Program: The State of Connecticut can help households pay for primary heating bills (i.e. oil, propane, electric, and gas). To be eligible, a household income must be less than 150% of the federal poverty income guidelines and the applicant must meet a certain limit for assets. If you have never applied and/or are interested in receiving more information on this program, please visit our website, <u>www.avonct.gov</u>, click "Social Services" under Deparments and use the "Energy Assistance & Renters Rebate" links, or call our office at (860) 409-4346 to see if you may qualify. Applications are by appointment only and the deadline is April 30th.
- **Operation Fuel** may be able to provide one-time assistance with heating bills for those households who have applied for the CT Energy Assistance Program and were found to be slightly over income/asset limits. All those interested must apply for the CT Energy Assistance Program before contacting Operation Fuel. More information is available through Gifts of Love at (860) 676-2323.

### Tax Relief For Elderly and Disabled Homeowners

In January 2017, the Town Council approved a two year extension of the Town's Elderly Property Tax Relief Program and raised the income limit from \$55,000 to \$57,500. Homeowners who are age 65 or older or totally disabled may be eligible for up to \$2,225 (for a married couple) or \$1,975 (for an unmarried individual) in property tax relief through the Town's Elderly Property Tax Relief Program. To be eligible, you must have been 65 or older by 12/31/17, your adjusted gross income plus social security has to be \$57,500 or less, and you must have owned your home on October 1, 2017. The application filing period is <u>February 1 through May 15, 2018</u>. 
#### 2017 Holiday Basket Program

#### **Plastic Film Recycling**

Instead these products should be taken to a location that accepts plastic film products so that these items can be appropriately recycled and made into materials such as composite lumber, new plastic bags, or packaging materials. #### **Reminders From the Avon Volunteer Fire Department**

- Snow Removal Reminder As the snow piles up this winter, please make sure to dig out any and all fire hydrants near your home or office. It is imperative that firefighters be able to access the hydrants quickly when needed.
- Check Your Smoke and CO Alarms The AVFD talks about replacing batteries when we change the clocks, but you should test your smoke and CO alarms monthly make sure they are working and they have not expired. To find out how old a smoke alarm is and its expiration date, simply look on the back of the alarm where the date of manufacture is marked. The smoke alarm should be replaced 10 years from that date (not the date of purchase).

We would like to recognize outgoing Town Council Chairman Mark Zacchio and outgoing Board of Finance Vice Chairman Thomas Gugliotti for their years of dedicated service to the Town of Avon.
