Annual Town Meeting

This issue of the Town newsletter is devoted to the proposed budget, which will be the subject of the May 6, 2013 Annual Town Meeting and the May 15, 2013 Referendum. The Annual Town Meeting is held for the purpose of presenting the Board of Finance's proposed budget to the voters; the Annual Town Meeting will not result in an increase or decrease in the budget that will be voted on at the May15th Referendum.

The Board of Finance held its Public Hearing on April 8th. On April 10th, the Board of Finance held their budget workshop with the Board of Education and Town Council and reached their final decision on the total budget.

As approved by the Board of Finance, and if approved by the voters at referendum, the overall 2013/2014 budget will be \$81,760,417. This represents a budget increase of \$3,030,624, or 3.85%, and a tax increase of 2.60%. The associated mill rate will be 26.32 mills.

At this point in time regarding the budget process, the Board of Finance will be presenting their proposed budget at the Annual Town Meeting on May 6, 2013. The Resolution that will be presented at the Town Meeting and the Referendum is as follows:

'SHALL THE ANNUAL TOWN BUDGET IN THE AMOUNT OF \$81,760,417 AS RECOMMENDED BY THE BOARD OF FINANCE FOR THE FISCAL YEAR COMMENCING JULY 1, 2013 BE APPROVED?'

At the conclusion of the discussion on the proposed budget, the meeting will be adjourned to a referendum vote on May 15th. Those eligible to vote include electors and taxpayers. Taxpayers are permitted to vote if they are at least 18 years of age, own property that has an assessed value of \$1,000 or more as of the October 1, 2012 Grand List, and are U.S. citizens.

Old Farms Road Project

Old Farms Road Project #04-129 - Pending CT DOT contract approval, the Town and C&C Consulting Engineers, LLC, will proceed with the necessary steps to execute the contract (10% local match) for an Environmental Assessment (EA) in accordance with the Scope of Work approved by ConnDOT on September 18, 2012. In addition to the services of C&C Consulting Engineers, LLC, the Town will be responsible to provide technical and engineering services required for the preparation of the EA. The Town anticipates that both contracts for the preparation of the EA will be approved and executed by July of 2013. The time to complete the EA is estimated to be 18 months. The first public informational meeting based on the above schedule will be held in the fall of 2013.

<u>Old Farms Road Bridge</u> - The Connecticut Department of Transportation is completing work for the preparation of final plans, specifications and environmental permits for the replacement of the existing bridge on Old Farms Road over the Farmington River. In addition to the replacement of the bridge, this project also includes the reconstruction of Old Farms Road between Tillotson Road and Route 10 and the construction of turning lanes at the intersection of Route 10 and Old Farms Road. ConnDOT indicated that they anticipate all necessary environmental permits will be attained by August of 2013. The anticipated date for bidding is December of 2013.

The Award-Winning Avon Free Public Library

Avon Free Public Library was extremely excited to learn in March that it was selected to receive the 2013 Excellence in Public Library Service award. Avon was nominated for its very popular series of programs commemorating the 150th anniversary of the American Civil War. Nominations were reviewed by an independent panel of out-of-state librarians who recognize two libraries; one that serves a population of under 15,000 and one over, for "an outstanding program or service to their communities." Nominations were judged on innovation, creativity, and leadership. Avon's series of programs, organized by librarians Tina Panik and Patrice Celli, not only found an electric and enthusiastic audience, but also built lasting partnerships with local community organizations and received national attention in being selected as a stop for the traveling exhibit, *Lincoln: the Constitution & the Civil War.* In addition to the recognition for the library, Patrice and Tina were also individually honored by the Connecticut Library Association for their work on this series of programs. They will be co-winners of the organization's Special Achievement Award, presented at CLA's annual conference in late April. Congratulations to Patrice, Tina, and everyone involved in this fantastic endeavor!

Tax Relief For Elderly and Disabled Homeowners

In March of 2012, the Town Council passed a two year extension of the Town's Elderly Property Tax Relief Program. Homeowners who were age 65 or older as of 12/31/12 may be eligible for up to \$2,100 for a married couple or \$1,850 for an unmarried individual in property tax relief. To be eligible, you must be 65 or older by 12/31/12, your adjusted gross income plus social security has to be \$45,000 or less, and you must have owned your home on October 1, 2012. <u>Applications must be received by May 15, 2013</u>. Reminders From the Avon Volunteer Fire Department

Brush Fires - While cold, snowy weather postponed the start of spring fire season this year, it's never too early to prepare. Downed trees and other storm debris can provide additional fuel for brush fires. Wind gusts and low humidity cause brush fires to quickly grow and spread. Most brush fires are started by humans – a discarded hot match or cigarette or a campfire that isn't properly extinguished. The Avon Volunteer Fire Department urges residents to take precautions. Propane Grilling - While a lot of people continue outdoor cooking on propane grills throughout the winter months, the smell of burgers and dogs on the grill is a definite sign of spring. Many gas grill fires happen when people either use a grill that has been left idle or has just had a refilled gas tank reattached. Check tubes and hoses for blockages as well as cracking, brittleness, holes, and leaks. Protect hoses from heat, either by moving them or using a heat shield. Check for leaks – if you find one, turn off the gas. Use grills outdoors, at least 10 feet away from buildings. Keep propane containers upright and do not store spare containers under or near the grill or indoors.
