

AVON CLEAN ENERGY COMMISSION
MEETING MINUTES
November 15, 2023

I. CALL TO ORDER

The meeting was called to order at 7:09pm by Chairperson Carrie Firestone in the Avon Room at the Avon Town Offices. Members Present: Carrie Firestone, Bernie Zahren, Christine Winter, Michael Dawson. Staff Member Present: Grace Tiezzi, Assistant Town Manager. Members Absent: Kim Stevenson, Michael Guerrero, Daniel Carvalho, Anagha Bhumireddy-Student Member.

II. APPROVAL OF THE PRECEEDING MINUTES

On a motion from Ms. Winter and second from Mr. Zahren, the minutes of the October 18, 2023 meeting were unanimously approved.

IV. COMMUNICATION FROM THE COMMISSION

Ms. Winter provided an update on the Senior Center event. Ms. Tiezzi stated that 46 homeowners have signed up for home energy audits. Ms. Winter provided some feedback and had a question about the use of diesel for the Town.

Ms. Tiezzi stated that essentially the use of diesel is based on the Town's snowplows and fluctuates based on the winter weather.

Mr. Zahren stated that conversion kits to convert diesel- or gas-powered vehicles to be hybrid are coming, but the technology is still in the embryo stage.

The Commission continued discussion regarding the Energy Plan and a celebration after the plan is approved.

Ms. Firestone provided an update on the Doug Tallamy lecture.

The Commission brainstormed opportunities for community involvement and potential events in Spring 2024.
