FY 2017/2018 Budget Process

The process is already under way to begin planning for the FY 2017/2018 budget that takes effect on July 1, 2017. All town departments have submitted their capital budget requests, and operating budget requests are due in early November. Residents who would like to attend the meetings (during which the details of the budget are discussed) may be interested in the following announcements.

Capital Budget Presentations will be held in the Selectmen's Chamber at Avon Town Hall, 60 West Main Street, on the following dates and times:

November 1, 2016 - Last day to register to vote <u>in person</u> to be eligible to vote on November 8, 2016. The Registrars of Voters will be in their office at 60 West Main

November 7, 2016 - Last day to apply for an absentee ballot.

Avon Village Center: Progress Update

The Avon Village Center planning and development effort is moving forward. In November 2015, the developer, the Carpionato Group of Johnston, RI, was granted a Master Site Plan approval by the Planning and Zoning Commission. Since that time, a number of things have happened to move this complex process forward.

Under current zoning regulations and Town ordinance, the Town has the ability to retain "peer review" or "third party" consultants to review the applications of large, complex projects, such as the Village Center. The Town secured an agreement from the developer to retain an architecture firm and an engineering firm with experience with similar development projects to lend their expertise to the project. Per Town ordinance, the developer pays the firms' fees and Town staff monitor and manage the peer review work and the funding. The Carpionato Group, the peer review team, and Town staff have met several times for productive discussions about the project. The goal of these meetings is to incorporate each parties' questions and comments about the project in order to reach a position that the Planning and Zoning Commission may view favorably, in order to move the project forward.

In April 2016, the Carpionato Group applied to the Planning and Zoning Commission to begin earth excavation for the first phase of the Village Center development. Initially, the developer proposed excavation on three separate parcels of land located west of Climax Road. As a result of discussions with Town staff and peer review consultants, during a public hearing before the Commission on July 13th, the developer agreed to make reductions to the scope of the initial application request. The Commission approved the excavation of one of the three originally proposed parcels at this time and also made a number of modifications to the application. Town staff met with the developer in September to discuss the final pre-excavation requirements prior to the start of work on the approved parcel. It is expected that this work will begin in early October 2016.

The next step in the process requires the developer to submit schematic plans for the first phase of the development to the Town for review. The schematic plans will show a significant amount of detail and will allow Town staff and the peer review consultants to work out any problems with the roads, buildings, and infrastructure before the plans are finalized and submitted for official review and determination by the Planning and Zoning Commission. Additionally, a public hearing is required as part of this process under current zoning regulations. We anticipate that a public hearing will be held in fall 2016 regarding these plans. The developer hopes to begin "vertical development" in spring 2017.

As you can see, this project is large and complex. According to Hiram Peck, Director of Planning and Community Development, "this project will not be completed in a short period of time, so we are able to make adjustments as we go. As long as the framework of development, including the infrastructure, is well designed from the outset, the rest will follow along smoothly as the project progresses." As such, the Department of Planning and Community Development welcomes all questions and comments on any aspect of the proposed Avon Village Center development. "In order to make the process informative for everyone, please come to our office as soon as the developer submits plans to the department and ask questions at that time," advises Mr. Peck.

The Planning and Zoning Commission meets the second and fourth Tuesday of the month at 7:00 p.m. in the Selectmen's Chamber. Every meeting and public hearing is open to the public and we encourage members of the public to attend and ask questions.

The Town looks forward to creating a unique development that is desirable for residents, businesses, and visitors in the near future.

CPR/AED Certified Town Staff

In support of police and fire personnel being designated as first responders, Automated External Defibrillators (AED) Units were placed in Avon police cruisers providing a vital link in the "Chain of Survival" when responding to a sudden cardiac arrest event. Subsequently, in 2011, the Town of Avon was designated as a HEARTSafe Community by the State of Connecticut Department of Public Health, having demonstrated a commitment toward ensuring Town residents and visitors receive the early lifesaving response proven to increase the chances of survival for such an event. In late 2015, the Town acquired two additional AED Units which were strategically placed in common corridors in Town Buildings #1 and #5.

The seven Town Hall staff members pictured above volunteered to be certified in CPR/AED and attended two days of extensive training conducted by the Farmington Valley Visiting Nurse Association in May 2016. Having quick access to an AED may be the difference between life and death in a sudden cardiac arrest event and we are fortunate to have concerned employees trained and equipped in the event of an emergency at Town Hall.



Social Services Programs

- ⇒ CT Energy Assistance Programs: The State of Connecticut can help certain households pay for primary heating bills (i.e. oil, propane, electric, and gas), if those households meet certain federal poverty income guidelines and limited asset tests. For the upcoming 2016-2017 winter season, you may call Avon Social Services to see if you qualify for an appointment (regardless of whether you are a new or returning applicant). The program for oil ends on March 31, 2017, and all others, April 28, 2017. If you would like more information on this program, please visit the Town website, (www.avonct.gov) under the Social Services link "Energy Assistance & Renters' Rebate," or contact the Social Services Office at (860) 409-4346 with any questions.
- ⇒ **Operation Fuel:** Operation Fuel provides one-time assistance with heating bills for those households who may be slightly over the income/assets threshold for government programs (like the one listed above). More information is usually available by December each year through Gifts of Love at (860) 676-2323. Please note: the household <u>must apply</u> for the Energy Assistance Program <u>prior</u> to contacting Gifts of Love.

Avon Public Schools Smarter Balanced Assessment 2015-16

The Smarter Balanced Assessment is aligned to the English Language Arts (ELA) and Mathematics State Standards. The charts provided below reflect how Avon students performed as compared to the districts with whom we are generally compared. Overall scores in ELA and Mathematics are reported in scale-score units. Within the scale-score range, there are four performance levels: Level 1 – Does Not Meet, Level 2 – Approaching, Level 3 – Meets, and Level 4 – Exceeds. The percent of Avon students who scored at Level 3 or above in ELA and Mathematics are shown in the charts below along with the State percent of students who scored at Level 3 or above.

DPW Snow Removal & Ice Control Operations and Guidelines

General: Avon Public Works is charged with the responsibility of responding to winter snow and ice events. Our goal is to keep streets passable and reasonably safe during the storm and to clear the streets, curb to curb, within 8 to 12 hours after the storm has ended. Our plow drivers work long hours in hazardous driving conditions, and we appreciate your patience during snow and ice events.

Snow Routes: The 112 miles of town roads (approximate) maintained by DPW are divided into 11 snow plow routes. One plow truck and driver is assigned to each plow route for the entire winter season.

Priorities: During snow events, the primary focus is to provide a safe travel way for cars and emergency vehicles on heavily traveled roadways. While snow is actively falling, plowing is generally limited to the center portion of the roadway to clear a path wide enough for one travel lane in each direction. As a winter storm subsides, more efforts can be directed to local roadways and cul-de-sacs. Depending on the severity of a storm, it can take up to 4 hours +/- to make passes on all streets in town. Snow removal often continues for 8 to 12 hours after snow has stopped falling.

Mail Box Damage: During the winter season, it is inevitable that some mailboxes and posts will be damaged during winter plowing operations. Avon's policy is to reimburse residents \$20.00 for mailboxes and \$65.00 for posts that are damaged as a result of <u>direct contact</u> with a town snow plow. Mailboxes that are damaged from the force of snow thrown against them or mailboxes that are located closer than 9-inches to the roadway <u>are not</u> eligible for reimbursement.

Frequently Asked Questions:



I live on a cul-de-sac and end up with significant amounts of snow in my driveway. Why? Plowing cul-de-sacs is one of the most challenging operations during a snow storm. Most properties on cul-de-sacs have frontages that are narrower than lots on a straight street. Therefore, snow must be pushed into a smaller space.

Why is snow pushed into my driveway by street plows? It is unavoidable and it is not done intentionally. Snow cast into driveways is an unfortunate byproduct of a very necessary service we provide. When we plow a street, we are simply moving the snow that is in the street off to the side of the street. The greater the amount of snow, the more snow that is deposited on the side.

Who is responsible for clearing snow in front of my mailbox? We plow the streets curb to curb, or as close as we can get. Whatever snow

is left in front of mailboxes is the responsibility of the property owner to remove (or at least to move in order for the mailbox to be accessible to the mail carrier).

Can I, as a resident, push snow from my property onto the sidewalk or street? NO! Town Ordinance restricts the act of pushing snow back onto a street and doing so may result in a fine of \$50 and/or liability if an accident is caused by this dumping of snow. Please be respectful of passing motorists expecting a clear street by not putting snow back onto the street. Remember, if you contract for snow removal, you are still responsible for where the snow ends up.
