Dear Parents, Staff and Concerned Citizens:

Good Afternoon. Last week, the district received information regarding a significant reduction of the funds we were slated to receive under the Open Choice Academic Grant. More specifically, for fiscal year 2015-2016, Avon received \$217,125.00 and for fiscal year 2016-2017, the district will receive \$101,225.00.

The funds received via this grant are used to provide academic support to all Avon students including but not limited to non-resident students. The funds are also used to support after school programs, transportation, hosting specific school-based programs and staff professional development.

At the same time of this notification, we were also made aware that there is a possibility Magnet School tuition would be increased as a result of the unanticipated reduction to the grant received by CREC. This would place an additional financial burden on the district given that an increase would exceed the amount budgeted for Avon students attending CREC magnet schools.

Frankly, the reduction of \$115,900.00 is draconian and the possible increase in the tuition amount for students electing to attend a CREC magnet school will have an adverse impact on all our Avon Public School students.

This most recently announced reduction comes on the heels of another reduction to state aid announced last spring of approximately 33% to the Education Cost Sharing grant funds received by the Town of Avon for offering public education.

Included with this message is a draft letter and other information to help you voice your concern about the reduction to the Open Choice Academic Grant if you so choose to do so.

Please contact our local legislators and the Education Commissioner and strongly urge others with whom you associate to do the same.
