### Annual Town Meeting & Budget Referendum

This issue of the Town newsletter is devoted to the proposed budget, which will be the subject of the May 2, 2022 Annual Town Meeting and the May 11, 2022 Referendum. The Annual Town Meeting is held for the purpose of presenting the Board of Finance's proposed budget to the voters. The Annual Town Meeting will not include a vote for the budget or result in an increase or decrease in the budget. The budget will be voted on at the May 11th Referendum.

The Board of Finance held its Public Hearing on April 4th. On April 6th, the Board held its budget workshop with the Board of Education and the Town Council and reached its final decision on the total budget. As approved by the Board of Finance, and if approved by the voters at referendum, the overall fiscal year 2022/2023 budget will be \$106,248,104. This represents a budget increase of \$4,986,945 or 4.92%, and an increase in the levy of 3.77%. The associated mill rate would increase from 34.21 to 34.61 or 1.17%.

The Board of Finance will present its proposed budget at the Annual Town Meeting on May 2, 2022 at 7:00 p.m. in the Avon High School Auditorium. The meeting will also be available to watch at home via a livestream. The livestream may be accessed by web at the following link: <u>https://meet.goto.com/536701477</u> or by phone by dialing 1-866-899-4679 and entering access code 536-701-477. The livestream access instructions will also be made available on the Town's website.

<u>Electors or taxpayers wishing to provide comment during the Annual Town Meeting must attend the meeting in-person at</u> the high school. There will be no opportunity for the virtual audience to provide comment during the meeting.

The Resolution that will be presented at the Town Meeting and the Referendum is as follows:

'SHALL THE ANNUAL TOWN BUDGET IN THE AMOUNT OF \$106,248,104 AS RECOMMENDED BY THE BOARD OF FINANCE FOR THE FISCAL YEAR COMMENCING JULY 1, 2022 BE APPROVED?'

At the conclusion of the discussion of the proposed budget, the meeting will be adjourned to a referendum vote on May 11th. Those eligible to vote include electors and taxpayers. Taxpayers are permitted to vote if they are at least 18 years of age, own property that has an assessed value of \$1,000 or more as of the October 1, 2021 Grand List, and are U.S. citizens.

### **Avon Transfer Station News**

On June 1st, the Transfer Station will begin selling annual permits online! Residents may access the permit purchasing website at: <a href="https://avonct.viewpointcloud.com/">https://avonct.viewpointcloud.com/</a>, Department of Public Works, or by visiting the Town of Avon website at <a href="https://www.avonct.gov">www.avonct.gov</a>. Go to **Departments** and select the **Landfill/Transfer Station** or the **Public Works** webpages. After purchase, permit tags will be available for pick up. Please bring proof of payment to the Landfill Office at 281 Huckleberry Hill Road during regular operating hours.

"Fee Free Saturdays" Residential Brush Disposal Program, the Transfer Station will again offer <u>no fee</u> brush disposal for both permit-holders and non-permit-holders on the following Saturdays from 7:30 a.m. to 12:00 noon (ends 1 hour prior to closing): April 23, April 30, May 7, and May 14. Proof of residency required. Note: Commercial landscaping firms assisting residents, must be accompanied by hiring resident. NO stumps! Please call the Transfer Station at (860) 673-3677 or Public Works at (860) 673-6151 with questions.

## Be Bear Aware! Dos and Don'ts for Living with Black Bears

**Do not** feed birds in the spring (starting in late March), summer, and early fall. **Do** clean up spilled seed from the ground.

**Do not** place your garbage curbside the night before your scheduled collection. **Do** put your barrels outside the morning of collection. Store garbage in secure, airtight containers inside a garage or storage area. Adding ammonia to cans and bags will reduce odors that attract bears. Periodically clean garbage cans with ammonia to reduce residual odor.

**Do not** store leftover bird seed or recyclables on a porch or screened sunroom as bears can smell these items and will rip screens to get at them.

**Do not** leave dogs outside unattended. **Do** keep dogs on a short leash when walking and hiking. A roaming dog might be perceived as a threat to a bear or its cubs.

Do not leave pet food outdoors or feed pets outside.

**Do not** place meat scraps or sweet foods, such as fruit and fruit peels, in compost piles. **Do** use electric fencing to protect beehives, agricultural crops, berry bushes, chickens, and other livestock.

Do keep barbecue grills clean. Do store grills inside a garage or shed.

**Do** call DEEP's 24-hour hotline at 860-424-3011 to report a black bear sighting. **Do** call the Avon Police Department, Routine Line at 860-409-4200 if you observe a bear that is damaging property or believed to be a threat. An Officer will be dispatched to investigate and contact DEEP if necessary.

## **Dog Registration**

On June 1st, the Town Clerk's Office will begin issuing 2022 dog licenses. Renewal notices will be mailed to all registered dog owners. To purchase a new dog license, please send a copy of the dog's information from your veterinarian which includes proof of valid rabies certificate, and spayed/neutered certificate. For renewals, please make sure the rabies vaccine is current and not past the expiration date indicated on your paperwork from the vet. Licenses fees are \$8.00 for altered or \$19.00 for unaltered dogs. Please send to: Avon Town Clerk, 60 West Main St., Avon, CT 06001-3719. Please make check payable to the Town of Avon. There is a \$1.00 penalty fee per dog per month if you fail to register your dog on or before June 30th. Remember that Connecticut law requires that all dogs be licensed.

### **News from Social Services**

**CT Energy Assistance Program:** The State of Connecticut can help households pay for primary heating bills (i.e. oil, propane, electric, and gas). To be eligible, the gross annual household income must be less than 200% of the federal poverty income guidelines, and the applicant must meet a certain limit for assets. If you have never applied and/or are interested in receiving more information on this program, please visit our website, <u>www.avonct.gov</u>, under the Social Services link ("Energy Assistance & Renters Rebate"), or, call our office at (860) 409-4346, to see if you may qualify. <u>Applications are by appointment only!
