## Save the Dates! FY 2023/2024 Budget Process

The process to prepare the FY 2023/2024 budget that takes effect on July 1, 2023 is well underway. All town departments have submitted their capital and operating budgets and **Town Council** will review the Town Manager’s proposed budget at a hybrid (virtual and in-person) **Budget Workshop** scheduled for Saturday, February 4th beginning at 8:00 a.m. and ending around 1:00 p.m. Details of the proposed budget will be presented and discussed with the Council at this time and the public is encouraged to attend.

The **Board of Finance** will hold a **Public Hearing** on the budget on **Monday, April 3rd** at 7:00 p.m., in a hybrid format (via GoToMeeting and in-person, location TBD). Residents wishing to provide the Board of Finance with input about the budget are welcome to attend and offer comments. Information regarding the process for making comments will be provided via the Town’s website prior to the public hearing. The **Board of Finance Budget Workshop** will be held on **Tuesday, April 4th** at 7:00 p.m., in a hybrid format (via GoToMeeting and in-person, location TBD). During the workshop, the Board will consider the comments from the public hearing and determine the budget that will be presented at the Annual Town Meeting and appear on the ballot at the Budget Referendum in May. Following this determination, changes cannot be made to the budget before the Referendum. Please note there is no opportunity for public comment at the Board of Finance Budget Workshop, but residents are welcome to attend.

We expect that the budget document will be posted in late January, and will be updated in March and again in May as the budget process progresses. We also recommend that you “**Subscribe to Town News**” on the Town’s website under **Citizen Action Center** to receive email notifications of Town Council, Board of Education and Board of Finance agendas, as these Boards have a direct role in the budget process. ## Tax Relief for Elderly and Disabled Homeowners

Homeowners who are age 65 or older or totally disabled may be eligible for **up to \$2,360** in Property Tax Relief. To be eligible, you must have been 65 or older prior to 12/31/22, your adjusted gross income plus social security has to be **\$61,800 or less**, and you must have owned your home on October 1, 2022. The application filing period is **February 1 through May 15, 2023**. ### Real Estate & Supplemental Motor Vehicle Taxes

The second installment of real estate and supplemental motor vehicle taxes (for those who purchased **OR** reregistered a motor vehicle after October 1, 2021 thru September 30, 2022), due January 1, 2023, must be paid or US postmarked by February 1, 2023 to avoid state-mandated interest charges. ## Early Voting was Approved in November. What Happens Next?

During the November 2022 General Election, voters approved a ballot question to amend the State Constitution to allow for early voting. The General Assembly, which convened for the 2023 legislative session on January 4th, has begun to draft legislation outlining the particulars of the new early voting system. A number of questions will need to be answered including, but not limited to, how long the early voting period will be, and how it will be funded.

The initial proposal will be developed by the Government Administration & Elections Committee (GAE) based on input from public hearings, election stakeholders and the Secretary of the State. From there, the bill will follow the standard legislative process. The public is encouraged to participate in the legislative process by calling, or writing to, your elected state representatives or to the Office of the Secretary of the State to share your ideas. You can also submit testimony during the public hearing process.

In order to prepare for early voting, the Town's Registrars of Voters (ROV) are asking the public to verify their voter information by visiting [www.avonct.gov/registrar-of-voters](http://www.avonct.gov/registrar-of-voters), selecting "Voter Registration" and scrolling down the page to find the link for the Voter Registration Lookup. The Registrars will also be looking to recruit poll workers as the need arises. ## Reminders from the Public Works Department

**Mailbox Damage:** During the winter season, it is inevitable that some mailboxes and posts will be damaged during winter plowing operations. Avon's policy is to reimburse residents \$20.00 for mailboxes and \$65.00 for posts that are damaged as a result of direct contact with a Town snow plow. Mailboxes that are damaged from the force of snow thrown against them or mailboxes that are located closer than 9-inches to the roadway are not eligible for reimbursement.

**Public Sand/Salt Mix:** A sand and salt mix is available to residents at no charge at the Public Works Garage and at the Landfill. Please limit yourself to (1) five-gallon pail.

## Winter Safety Tips from Animal Control Officer Angela

When it comes to winter preparedness, we can't forget our pets. The Town's new ACO, Angela Grano, is pleased to share the following tips to help keep our furry friends safe and sound throughout the winter months:

- Check their skin and paws often for cracks or drying. Stay off salted roads during walks.
- Ensure access to fresh, unfrozen water as winter temperatures can cause excessive dryness.
- Watch their weight as pets are less active in the winter.
- Check your car engine and tires before starting your car. These are warm places for indoor and outdoor cats to nap. Also check for antifreeze leaks.
- Most pets are not equipped to handle extreme cold. Consider booties and/or jackets to keep short-haired breeds warm.

## Special Town Meeting to Consider Purchase of Fire Apparatus

The Town Council has scheduled a Special Town Meeting on Tuesday, January 24, 2023 (Snow Date: Monday, January 30th) at 7:00 p.m. at Avon High School to consider resolutions appropriating funding and authorizing the issuance of bonds of the Town to purchase a new fire engine (\$1,259,000) and a new ladder truck (\$2,172,000) for use by the Avon Volunteer Fire Department. During the Special Town Meeting, the purchases will be proposed and discussed and at the conclusion, the moderator will call for a hand vote on the purchase of each vehicle. The purchases would be approved if a majority of those persons present at the meeting and qualified to vote, vote "yes." The vehicles will be considered independently of one another, with a separate hand vote conducted for each purchase. ## News from Social Services

- ◆ **CT Energy Assistance Program:** The State of Connecticut can help households pay for primary heating bills (i.e. oil, propane, electric, and gas). To be eligible, the gross annual household income must be at or below 60% of the state median income. If you have never applied and/or are interested in receiving more information on this program, please visit our website, [www.avonct.gov](http://www.avonct.gov), under the Social Services link (“Energy Assistance & Renters Rebate”), or call our office at (860) 409-4346 to see if you may qualify. **Applications are by appointment only! Program deadline is May 31st.**
- ◆ **Operation Fuel** may be able to provide one-time assistance with heating bills for those households who have applied for the CT Energy Assistance Program and were found to be slightly over income/asset limits. ## Bicycle & Pedestrian Master Planning Effort to Commence

In December 2022, the Town Council awarded a contract to the SLR International Corporation of Cheshire, CT to develop a town-wide Bicycle & Pedestrian Master Plan. The goals of the plan are to improve mobility, connectivity, recreational opportunities and public health. The plan will also aim to enhance sustainability by encouraging non-motorized or public transportation options. Project deliverables will include a prioritized list of recommendations for new or improved bicycle and pedestrian connections and facilities, along with policy and operational recommendations.

The Town expects to begin working with the consultant this winter and anticipates that the project will take approximately a year to complete. The consultant’s scope of work includes a robust public involvement process throughout the project that will include a variety of events aimed at engaging a broad cross section of the Avon community in the process. ## Old Farms Road Phase I (North-South Section) to Proceed

The Town held a referendum on December 14, 2022 to consider the appropriation of \$5.4 million in state grant funding to complete the Old Farms Road Phase I (North-South Section). The appropriation was approved with a vote of 1,330 in favor to 1,018 opposed. As of this writing, the Town and its engineering consultants are finalizing the project design and permitting and preparing the bid documents. We anticipate advertising an invitation for bid in the coming weeks. We expect construction to begin in spring 2023. ## Winter Tips for Outdoor Cycling, Running & Walking

*Stay Safe all winter long with these tips prepared by Bike Walk Avon CT, the Department of Recreation & Parks and the Police Department:*

1. **Go "Hi Viz."** Lights and high visibility clothing are essential. Bikes should have front and rear lights. Pedestrians should carry lights or use a head lamp when it's dark. Clothing should be light in color and have reflective strips.
2. **Ride, Walk & Run Defensively.** Make eye contact with drivers, limit sudden movements, and always sign with intent. Cyclists should ride with traffic and obey all traffic signs and signals. Pedestrians should walk against traffic while on a road and use sidewalks and crosswalks when available. Crossing beacons are available for your safety on our rail trail.
3. **Adapt your Activity.** Falls are more common in the winter months. Cyclists should slow down and remove their pedal clips and straps. Slower speeds help adjust to the variability in winter conditions.
4. **Layer Up.** New England weather changes quickly. Layers make temperature adjustments easier. Much better to prepare for the cold and remove layers if needed.
5. **Protect your Eyes.** Even if the sun isn't shining, wear glasses to protect your eyes from the wind, glare, dirt, grit and anything else that could be kicked up from the pavement.
6. **Wear a Helmet.** Helmets for cycling are essential year-round. Be sure your helmet fits over a hat.
7. **Don't Forget to Eat & Drink.** In the winter, we generate more body heat to resist the cold and to maintain constant body temperature. The air is usually drier in the winter, and the sweat produced during exercise can cause dehydration.
8. **Let Someone Know Your Plans.** Make sure you communicate where you are going and when you plan to return.

## Reminders from the Avon Volunteer Fire Department

The AVFD wishes all a safe and healthy 2023! We would like to thank all those who supported us in 2022 through financial contributions, donations to food and toy drives, and much more. We are grateful for your generosity.

**Snow Removal:** Please dig out all fire hydrants near your home and office whenever it snows. Immediate access to a water source in an emergency is absolutely crucial to the protection of life and property.

**Smoke and CO Alarms:** Test your smoke and CO detectors monthly. Confirm they are not expired by checking the manufacture date on the back. Detectors should be replaced within 10 years of the manufacture (not purchase!) date. Place one on every level of the home, including the basement, one in every bedroom, and one outside of sleeping areas within 10 feet of a bedroom door (per State of CT).
